

5. Sealed Quotations must be submitted to the above on or before 12:00 Noon on 2077-07-19 . Quotation received after this deadline shall not be accepted.
6. Quotations must be valid for a period of 45 days after opening of sealed quotations and must be accompanied by Cash Security or Bank Guarantee, amounting to a minimum of *amount as specified in table above*, which shall be valid for 75 days after opening of the Sealed Quotations.

If bidder wishes to submit the Cash Security, the cash should be deposited in Deposit Account No.: 4170100202030000 of Pradesh lekha niyantrak karyalaya, sudurpaschim Pradesh dhangadhi, at *Rastriya Banijya Bank, Dhangadhi, Kailali* and submit the receipt of the deposited amount of cash along with the Sealed Quotation.
8. Sealed Quotations shall be opened in the presence of Suppliers representatives who choose to attend at 2:00 PM on 2077-07-19 at the Ministry of Internal affairs and Law, Dhangadhi, Kailali. Sudurpaschim Pradesh.
